CONFERENCE OBJECTIVES

The FSPHP 2024 Annual Education Conference will focus on the following education objectives:

- Identify the next generation of prevention and outreach strategies for healthcare professionals.
- Examine the day-to-day operation of PHPs by focusing on positive benefits, as well as the challenges that impact desired outcomes.
- Examine and propose practices to improve confidentiality, reduce stigma, and remove barriers for help-seeking to increase utilization of PHPs.
- Share and propose exemplary administrative, funding, legal, monitoring, and case-management policies and approaches that increase access to care, improve the participants' experience seeking services and/or being monitored, and contribute to evidence-based outcomes.
- Demonstrate how research, public relations, and outcome reporting foster an increased understanding of the benefits of professional health programs and the significance of health and well-being initiatives.
- Describe and compare the unique characteristics of the evaluation and treatment of healthcare professionals through a safety-sensitive lens that positively impacts health and well-being outcomes and public safety.
- Compare and discuss how PHPs interface with institutional wellness programs.

ACCREDITATION OVERVIEW

Activity Goal

This activity is designed to address the following core and team competencies: patient care, medical knowledge, employing evidence-based practice, interprofessional collaboration, and communication.

Accreditation

In support of improving patient care, this activity has been planned and implemented by Cine-Med and the Federation of State Physician Health Programs. Cine-Med is jointly accredited by the Accreditation Council for Continuing Medical Education (ACCME), the Accreditation Council for Pharmacy Education (ACPE), and the American Nurses Credentialing Center (ANCC), to provide continuing education for the healthcare team.

Physicians

Cine-Med designates this live activity for a maximum of 14.25 *AMA PRA Category 1 Credits™*. Physicians should claim only the credit commensurate with the extent of their participation in the activity.

Nurses

This activity provides 14.25 contact hours for nurses.

Pharmacists

This activity has been accredited for 14.25 CEU (14.25 credit hours) of continuing education credit.

Note: Due to CPE Monitor reporting requirements, all pharmacists' credits must be tracked and submitted into the Cine-Med Credit Tracking page within 30 days of the conference.

Psychologists

Continuing Education (CE) credits for psychologists are provided through the co-sponsorship of the American Psychological Association (APA) Office of Continuing Education in Psychology (CEP). The APA CEP Office maintains responsibility for the content of the programs.

This activity is approved for 14.25 CE Credits.

Social Workers

As a Jointly Accredited Organization, Cine-Med is approved to offer social work continuing education by the Association of Social Work Boards (ASWB) Approved Continuing Education

(ACE) program. Organizations, not individual courses, are approved under this program. State and provincial regulatory boards have the final authority to determine whether an individual course may be accepted for continuing education credit. Cine-Med maintains responsibility for this course.

Social workers completing this course receive 14.25 intermediate continuing education credits.

Dentists and Oral Health Professionals

Cine-Med is an ADA CERP Recognized Provider (January 1–December 31, 2024). ADA CERP is a service of the American Dental Association to assist dental professionals in identifying quality providers of continuing dental education. ADA CERP does not approve or endorse individual courses or instructors, nor does it imply acceptance of credit hours by boards of dentistry.

Cine-Med designates this activity for 14.25 continuing education credits.

Other Healthcare Professionals
