This one-hour interactive session will begin with a brief expert overview of best practices for Health Professional Programs managing complex mental health cases, followed by two case presentations. Participants will then move into breakout groups to brainstorm their approach to each case, identify appropriate referral options and resources, and outline strategies for ongoing PHP case management. Each breakout will assign a reporter to present the group's recommendations back to the full audience, creating an opportunity to compare approaches, surface practical resources, and define what a successful PHP experience looks like in these complex situations.

Worksite Monitoring: Guidance for Programs and Participants

Facilitated by Becky Carlson, LMHC & Kay O'Shea, MAC, CADC, CTP

As licensing boards increasingly remove health-related questions on applications, worksite monitoring is becoming a critical component of ensuring safe practice and supporting participant success. However, confusion persists around the role—particularly the distinction between worksite monitors, practice monitors, mentors and sponsors.

This session will clarify the purpose, scope, and expectations of worksite monitors, including how they differ from other monitoring roles. Participants will gain practical guidance on identifying and selecting appropriate monitors, including considerations for choosing a qualified and effective peer, and what successful monitoring relationships look like in practice.
