

A Progressive Step Toward a Model Physician Health Program Safeguarding California's Physicians and Patients

The Medical Board of California (Board) has made great progress on its efforts to obtain a legislative change to its authority to establish a Physician Health and Wellness Program that meets nationally recognized best practices seeking FSPHP expertise along the way.

Assembly member Marc Berman has introduced [Assembly Bill 408](#) which proposes to repeal current legislation that requires imposition of the Uniform Standards Regarding Substance-Abusing Healing Arts Licensees for voluntary participants and grants new authority that will allow the Board to create a program that meets best practices.

It is helpful to legislative staff if letters clarify a position (in favor or not) at the beginning of the letter.

While FSPHP is still reviewing the legislation, we recognize many key advantages that align with the FSPHP PHP model, such as:

1. **Workforce Protection Through Early Intervention:** Replaces punitive approaches with rehabilitation, encouraging help-seeking before impairment occurs. This reduces liability risks while protecting patient safety.
2. **Confidential Record Protections:** Shields records (except for imminent safety risks), addressing physicians' fears of licensure penalties and promoting timely care.
3. **Balanced Reporting Requirements:** Reporting for those at risk of impairment while also offering protections for reporters, encouraging a culture of accountability.

4. **Voluntary Alternative to Discipline:** Mirrors successful 48-state programs, enabling physicians to seek help without career-ending consequences.
5. **FSPHP Best Practices Integration:** Requires third-party administration by accredited nonprofits, ensuring evidence-based care and peer review.
6. **Clear Regulatory Framework:** Defines roles for the Medical Board and administrators to minimize ambiguity.

Why a PHP in California Is Critical:

- **Substance Use Disorders:** Lifetime prevalence: 15.3% of physicians (~18,963 CA MDs). Current need: 620–4,710 CA physicians require immediate SUD support.
- **Mental Health Crises:** Burnout: ~62,000 CA physicians affected (50% nationwide). Suicide rates: Twice the national average, with CA likely accounting for 12% of U.S. physician suicides annually.
- **Proven Success:** PHPs using this model achieve **80% recovery rates** for physicians—far exceeding general population outcomes.
- **The PHP Model is supported by** the Federation of State Physician Health Programs, and medical leaders as a national best practice.

Now is the time to move forward:

AB 408 addresses the state’s physician health crisis by balancing oversight with compassion. By adopting this model, California will:

- **Retain physicians** in a state facing a projected 10,000-provider shortage by 2030
- **Reduce medical errors** linked to burnout and untreated SUDs
- **Rejoin the FSPHP network**, leveraging decades of evidence-based care standards.
