Licensing, Credentialing Moves that Support Well-Being on Upswing

Physician well-being is taking center stage as licensing and credentialing processes evolve to remove stigmatizing language that once discouraged doctors from seeking mental health care. The AMA reports significant progress, with more medical boards and hospitals adopting policies that focus on current impairments rather than past treatments. These changes aim to create a safer environment for physicians to access the support they need without fear of professional consequences.
